MINUTES APPROVAL:

A motion was made to approve the minutes of the March 24, 2011 Board of Selectmen meeting.

COMCAST CONTRACT:

Mr. Cullinan stated actions will be taken during the next Selectmen's meeting scheduled for April 28, 2011 regarding this contract due to the IBEW Union wanting to speak on the campaign for union recognition. Mr. Jack McCarthy and Mr. Paul Feeney of the local union requested the Town pass the resolution and include it in the Comcast contract that is up for renewal. Mr. McCarthy and Mr. Feeney stated it is essential to have well qualified workers who meet high standards and abide by the labor laws.

FY12 WARRANT:

Mr. Cullinan stated there were no changes to the Warrant and it will be reviewed at the next scheduled meeting on April 28, 2011.

SINGLE PRECINCT:

Mr. Cullinan stated that Mass General Laws require towns to divide into precincts after each federal census and needs to officially request the Secretary of the Commonwealth to prepare a single precinct map on our behalf.

BEAR POND UPDATE:

Mr. Cullinan stated the results of retesting the chromium at Bear Pond was good news and it is naturally occurring rather than toxic.

STORM WATER MANAGEMENT PLAN:

Mr. Cullinan stated the Town has completed the annual Storm Water Management Plan and suggest the Board of Selectmen approve this plan.

Mr. Cullinan publicly recognized FF Antrim for taking the initiative and applying for a homeland security grant and pointed out that he was approved for the amount of \$91,186.00 to be used for public safety equipment for the Fire Department. Ms. Titus and Mr. Lombard stated that Mr. Antrim is a great addition to the department and thanked him for his efforts. Mr. Cullinan read the letter for the record.
