- 5. Town Administrator Report
- a. Johnson Elementary School COVID reopening update.

The School Committee, The re-opening committee and Patty Sheehan have been a big help with the re-opening plan.

6. Citizens Forum

Cora Long- Asked if there was a discussion on raising tax fees for multi families

TA- Trash bills are late this year, have been delayed to reconstruction of contract. Negotiating during a time where trash fees/rates are increasing globally and locally due to restrictions. The town only signed a one year contract due to the uncertainty of the revenue, pollution restrictions, and coronavirus. Trying to decrease fees. The fee for a single family home and a multi-family home is the same fee right now.

GC- Asked how to charge tax if it is an Air BnB

TA- We currently do not have a tax for an Air Bnb regarding trash.

Candace Cahill- Asking why the meeting is no longer televised. Wondering why they are not televised.

TA- Unfortunately due to covid we have to host the meetings virtually. We are trying to find a way to show the meetings on zoom and tv.

Shannon Bianchi- Asked for an update on the coverts on castle road and the drainage system issue.

JA- The town, DPW, and the town engineer are working hard to come up with the best plan to resolve the issue.

Alice Cort- Asked if there is going to be a change in the distribution of the warrant.

JA- the warrant will be printed and mailed

Peggy Silva- Also asked if there is a way to have the second statement printed and mailed.

Michelle Capano- New members were recently appointed to the Advisory and Finance committee and wants to know why those positions were not made publicly available to all residents so they could apply through town moderator.

JA- That is an appointed board by the moderator. The moderator tries to keep that board somewhat separate from the Board of Selectmen.

TA- When someone resigns from that board they inform the Town Clerk and the Moderator and the Moderator takes on the process.

JA- We will need to find out a better process to improve the process.

Debbie Vanderslice- Asked if there is a better way to post the open positions online. Asked if there is a rule/law that the town or committee must post the open position for a certain period of time before being appointed.

Dan Skrip- Not aware of anything that requires the advertisement of an open position.

Cynthia – Asked about parking stickers and daily parking passes.

TA- Temporary parking/daily passes have been limited this year due to the amount of non-resident parking issues we have had. Due to coronavirus there is less parking as well.

Bonnie D'Orlando- Asked if the Board of Selectmen statement be updated with the three recent court decisions.

JA- It can be updated with another statement we can share.
