1. Meeting Opening 6:30pm

**MC**- Opened Joint Meeting with the Board of Selectmen and Board of Health at 6:30pm on December 17, 2020 via Zoom.

**a.** Coronavirus update with Health Nurse Deborah Murphy and Health Officer John Coulon

**Deborah Murphy-** Weekly numbers in the state of Mass reported at 4,985 new cases, with a 6.02% positivity rate. Nahant's numbers from 11/29/20-12/12/20 is 16 new cases with a 35.3% daily incident rate. Nahant now in yellow zone. Chelsea, Lynn and Revere numbers are very high and they are the top highest in the state. Swampscott is now in the red having 140 new cases in the last 2 weeks. Marblehead had 140 new cases in the last 2 weeks. Nahant has 9 Active cases with the average age of 42. The states average age is 38. We do not know where the cases are coming from, how/where people are originally contracting it. Thanksgiving did not increase numbers. Four out of five of Nahant's active cases were directly related to the person's workplace. There has been no school transmission. Swampscott schools are going 100% remote starting Monday until

January 8<sup>th</sup>. The covid testing in Nahant has been going good and well attended. A few people have had trouble getting/accessing their results.

John Coulon- Annual Food Inspections have been conducted and on track to complete. We do inspections prior to approval of annual liquor licenses and common victualler licenses. Each inspection includes discussion of COVID 19 compliance. It includes weather the staff is using masks properly, are masks being made available to customers, does management have a plan of response to a COVID 19 exposure. Checks how the facilities air handling capabilities are. Look at frequency of surfaces being cleaned. Looking into funding for Local Boards of Health and representation at the state level.

MC- Testing in Nahant will be tomorrow Friday 12/18 at St. Thomas from 11-1. Next week 12/22 and 12/23 from 11-1 at St. Thomas. The following week 12/29 and 12/30 at St. Thomas from 11-1. Nahant residents can still go to Swampscott at 585 Humphrey St. Mon-Fri 2:30-6:30pm and Saturdays 8am-12pm.

## 4. Ongoing Business

a. Preserving East Point-continued discussion

MC- We are still waiting for the financial impact report hoping to have it before the end of the year. The concom scheduled a meeting for a Notice of Intent on December 21<sup>st</sup> 2020 via zoom. We had asked the state to extend the Chapter 53 requirements and we have not heard back.

# 5. Town Administrators Report

a. MA DEP Administrative Consent Order

Dan Skrip (Town Counsel)- This was an Administrative Consent Order and Administrative Action by the DEP which means that the DEP was alerted to our two major water main ruptures back in June 2019 and June 2020. It is looking into how we are dealing with water runoff and sewer issues. Due to the breach that is a regulatory violation so the DEP needs to respond. It is a friendly event and the DEP is just making sure we are taking care of the situation and making plans to improve our waste water system and to do our best to make sure it doesn't breach again. This order is setting forth a plan, which we have already started complying with already, we have already submitted draft bylaws for infiltration and inflow, we have already submitted a cctv engineering report. We now need to execute the consent order which sets into play a few other deadlines to meet. Once the effective date of the order begins we have 45 days to provide our emergency response schedule, Zach is working to with Wright and Pierce to make that happen. On September 1, 2021 our implementation schedule is due and at the end of 2021 we should be at a substantial completion date. All of these dates have been approved by Coughlin Engineering and Wright and Pierce. There was a fine for the violations that was under 10,000\$ but it will be waived as long as we maintain the timeline. Once the Administrative Consent Order is signed I will

create a timeline to make sure we are on pace. The Town Administrator cannot sign the Consent Order without the Board of Selectmen authorization.

The Legislative Act that created the act of the Town Administrator requires the Board of Selectmen to inform the Town Administrator weather or not they are going to negotiate a new contract with him/her 6 months prior to the contract expiration. The current TA Tony's contract expires in June.

#### **6.** Citizens Forum

**Rose Cort**- Stated "At the Planning board meeting this week, there was an indication that after storms the pump station near Northeastern registering as pumping in volumes which led to concern that broken sewer pipes are absorbing storm water which effects residents fees. A member of the board indicated that NU refused to allow a town consultant engineer to inspect the sewer pipe that runs through the property. Do you have any information?

**Dan Skrip (**Town Counsel)- Because Northeastern produces so much waste water we had to come up with a draft bylaw that causes them to have increased vigilance in terms of monitoring their waste water systems.

MC- So there may be inflow coming from Northeastern that is unneeded and unsure exactly where the extra inflow is coming from, it may be easy to find out since there is a pump station at the corner of Northeastern and Nahant road that receives waste water from the East Point neighborhood which is Cliff St, Vernon St, and Nahant Rd. So about 15-20 houses contribute waste water to that pump station. We can look at the run times on our pumps and figure out how much waste water we are pumping from there and it is a 100x more than what is being contributed from those houses. So the extra inflow is coming from somewhere. Further investigation needs to take place.
