1. Meeting Opening 6:00 pm

Mr. Cullinan made a motion to open the Wednesday, July 22 BoS meeting at 6pm Seconded by Mr. Canty

- a. Coronavirus Update with Health Nurse, Deb Murphy and Health Officer, John Coulon
 - i. Statistics
 - ii. Review of local orders

Health Nurse Deb Murphy- We haven't had a positive case since June 12th, but starting this week already we have four new cases. The age group of the residents that are starting to test positive are much younger. As of last Wednesday, July 15th we had 557 residents who had been tested. Camps, sports a lot of re-openings during phase three. We have had cases on the golf course, outdoor lessons...this is a good time to remind people of the restrictions and precautions to safely take.

Health Officer John Coulon- provided an update regarding covid and ways to avoid a potential second wave.

2. Opening Comments

Mr. Cullinan read aloud the following comments;

- a. Available seat on Board of Assessors and Planning Board. Applications were due July 20, 2020. Vote for interims will take place on August 5, 2020.
- b. The Nahant Fire Department is seeking applicants for the position of Call Firefighter Mr. Cullinan spoke about hot weather and crowds surfacing. There were two issues; the causeway/parking lot and boats (specifically forty steps and short beach) close to two boats togethers. Very loud, very noisy.

TA One thing that we need to understand is that the entire state experienced this issue. A lot of it has to do with Covid reasons. No operating sumer camps, summer school, sports, people are not going on vacation. This is a contributing factor. Some existing issues is the reconstruction of the causeway and reduction of parking spots. Infrastructure upgrades that would need to happen that takes time and there are policy making processes that we can explore with DCR.

Lietanent Shultz – reiterated what the TA stated. They are doing everything they can to work with these issues. Chief Dwyer will try to reach out to the State police to help out.

Mr. Antrim regarding the boat situation; we are having situations of close to twenty boats tying up. The Harbormaster needs a rule to follow in order to enforce anything. We are looking into limits of number of boats rafting up and number of total boats in a confined cove.

Mr. Cullinan ok, we will follow up with you Tony. Get some input from the Harbormaster and draft a policy for the Board to vote on.

TA Yes, I will also work with Dan and John Coulon. I think under the Covid regulations, we might have some relief.

Jen McCarthy- Is the Town reaching out to DCR and asking for more police presence on the causeway?

TA Yes, we are in communication with State police

Christine Liscio- Can we make sure the Lifesaving lot is locked?

TA I can reach out to Emily Potts and confirm they are locking regularly.

Michelle Capano- would the BoS consider raising the penalty violation for non-resident parking tickets?

TA Dan, Chief Dwyer and himself have been looking into it. We hope to put some type of proposal in front of the BoS.

Colleen O'Neil- can we put barriers between the two lanes so residents can get down the causeway to their homes?

TA We have talked to DCR about it, but we can bring it back up again.

Mr. Canty who has a level of responsibility on the causeway?

TA The Nahant Police has the details and we respond to emergency calls. The State police has jurisdiction as well. DCR runs the causeway and the Police Police and Nahant Police have jurisdiction on issues.

Mr. Antrim- Nahant does not pay for those details.

TA correct, the State pays for those.

d. 6 Antigo Way easement discussion

Mr. Frank Cardile- as my letter to the Board stated; 1946 all three of our houses on Antiwo Way, my family bought. In 1980, we bought it from our family trust. Around 1980 we applied for a permit and it was granted after non conforming variance, to put an addition on. They referred to a plot plan from 1946 showing plenty of frontage to the property. We proceeded with the improvements. House has not been improved since 1980. Over time we wife and I have seen different maps showing different findings. So we hired Ralph Reed to do a new plot plan which is dated July 2, 2020 showing ~192 sq ft encrouching Antigo Way. It does not impact any of our abutters and it doesn't impact the Town. We are basically asking if we can aquire that piece of land through easement.

Mr. Cullinan asked Town Council; Dan Skrip what the process would be.

Dan Skrip- Town Meeting is required to authorize the BoS to dispose of the property and a Town Meeting vote to discontinue that portion of the right of way. We would then give it to the Town Owned Lan Study Committee and they would provide a recommendation. And then its up to the Selectmen with regards to selling this property. This is a lengthy process that we can start.

Mr. Antrim asked if there was was minimum width required of the road?

TA that is something that the Town Owned Land will look at and recommend.

Mr. Antrim I would be in favor of opening the warrant and adding this article

Mr. Cullinan stated that he supports that action and asked Dan Skrip if he could have a draft article for this topic?

Dan Skrip stated yes, we will have it ready by next BoS meeting (August 5th).

e. Bayside Function Room: Outside dining premises expansion approval

TA We received a request similar to what we have seen from other businesses in Town. They are looking to utilize the temp. authority to expand their current common vic license and current liquor license premises to the outside area.

John Byrne from the Bayside represented and spoke on behalf of the Bayside Function Room.

A discussion between the Board, John Byrne and Dan Skrip regarding the Bayside Function Room took place.

c. Vote to approve MOAs for terms of the FY20 and FY21-23 CBAs with the Department of Public Works

5. Town Administrator Report

a. Flash Road basketball and tennis court

TA Town meeting approved \$160,000 of CPC money for the project to completely redo the basketball and tennis courts at Flash Road park. We bid it out for construction. The received bids came in higher then our funded amount. We need to figure out a way to find additional funding.

Mr. Cullinan asked Tony if he considered contacting the lowest bidder and asking for them to hold on this project until we go to Town meeting in September to appropriate additional funds.

b. Upcoming water main work

TA We had a water pressure issue throughout the community yesterday. That was caused by a leak on the causeway in the parking lot (on the causeway). We were able to slowly and carefully restore pressure. We have an emergency repair on the causeway to the 14' main that will take place over the next day or two.

The scheduled water main upgrades on Walton Road, Furbish Road, Mills Terrace and High Rd. These upgrades are funded by MWRA loans (approved at Town Meeting). These are part of the capital plan. This work is scheduled to begin mid-late August and likely take 3-4 weeks. Residents will be notified of this work. They will be replacing a 2" water main along Furbish Road with an 8" main. The section of 2" main on Walton Road will also be replaced and connect with the existing 8" main on Forty Steps Lane. Also adding new fire hydrants in the area. On Howe Road the 6" main is going to be replaced with an 8" main, as well as on Mills Terrace.

c. Castle Road and Fox Hill Road flood mitigation plan

TA There is a citizen's petition warrant article for this Town meeting on this subject. I think the next step should be to schedule a follow up meeting with Zach, one of the Board members, the neighbors in that area of Town and myself. TA provided a recap on some of the work that has been done since I have come on board.

*A discussion between the Board and TA regarding this topic took place.

Mr. Cullinan believes this is a mitigation issue and that at the very least a short term plan for this quickly approaching hurricane season should be put in place. Mr. Cullinan opened the floor for residents to speak. We need to figure out a way to mobizile those pumps for this fall.

Mr. Antrim agreed that a committee meeting on this specific topic to disucss these details would be ideal.

Christine Liscio- likes the idea of a short term plan being implemented immediately. This is not a neighborhood issue. This is a townwide issue. She really appreciates the town's sense of urgency and support.

d. Status report on vacant boards and committees

TA This topic has fallen through the cracks over the past few years. The goal is to understand exactly where vacancies lie, then announce a the collective vacant seats and then how people can apply for those seats. We are also introducing this process to the new Town clerk. This is an ongoing process. We will continue to work on it.

Mr. Cullinan is a little concerned with certain seats being vacant now for over a year. He doesn't believe it is necessary to continue to delay appointments of those seats. I think we can do both. Fill the seats and continue to figure out the whole picture our committees. The remaining Board members agreed with Mr. Cullinan

TA agreed that he needs to make this more of a priority and make progress.

6. Citizens Forum

Resident from the Zoom chat: K Alice- Any movement on handicap accessible beaches and parking? Thought the grant was given in the spring. I can't get my dad, a life time Nahanter, down to any beach. I also have a loved one who has a hard time accessing beaches.

TA That is part of the MVP grant. I'm meeting with Applied Coastal in the next two weeks to see their comceptual plan which then will be broadcasted to the public in a public forum. This grant doesn't include Wharf Beach and Tudor Beach.

Michelle Capano- can you provide an update of when Annual Town Meeting will be held? TA We are zeroing in on the last Saturday of September. This will be on the agenda at our next BoS meeting.

Candice Cahill stated that there are two openings right now for Boards and wondering why this opportunity can't be announced?

TA We are hoping to make some appointments in the coming days. Covid has been making things a bit challenging but we are working on it.

A brief discussion between Candice and TA occurred.

Mr. Cullinan circled back to the earlier handicap beach access topic. He thinks next year we should think about access at the Marjarom park beach and Tudor Beach.

Deborah Vanderslice- With regards to the boats typing up at Forty Steps and other locations; the state already has laws regarding this topic. She offered to send TA the guidelines.

Ken Carangelo what is the status for Coast Guard Housing?

TA refaulted the question to the Coast Guard Housing Committee. Covid may be causing some delay. A brief discussion between Town Council and TA took place

Michelle Capano asked if BOS 2^{nd} Statement could be available at public buildings in Town? TA yes for the Town Hall. He will check with the Library to offer as well.

Mr. Cullinan asked TA if we still have an ADA Coordinator in Town? TA I don't think that they are active but I believe there is someone in that position.
