

1. Meeting Opening 6:30pm

Attendance; Mark P. Cullinan (MC), Joshua A. Antrim (JA), Eugene Canty (GC), Antonio Barletta (TA)

MC-opened the Joint Meeting of the Nahant Board of Selectmen & Board of Health at 6:30pm.

a. Coronavirus update with Health Nurse Deborah Murphy and Health Officer John Coulon

Deb Murphy: Currently 14 active COVID cases. Age group with highest positive cases is from 0-19 and the second highest is 20-29. Lynn, Swampscott, Marblehead and Chelsea are all in the yellow, Nahant is in the grey and Revere is in red. In the last 14 days we have had 547 people tested with 9 positive cases. Large cluster of positive cases at Swampscott High School from a gathering held. Starting Monday March 22 a new group of people become eligible for the vaccine. Lynn vaccine center will be expanding to meet the demand. About a 1/3 of Nahant residents have been vaccinated.

John Coulon: On Monday March 22 the state will move into phase 4 step 1. Gathering limits for public venues go to 150 outdoor and 100 indoors. Private property stays at 25 outdoor and 10 indoor. Ball parks opening to 12% capacity. Dancing allowed on dance floors. Travel orders change to a travel advisory. There are people who will be exempt from the advisory.

TA: Anyone looking to put in an Event Request with the town, we added a cover letter to our new form asking the coordinator to provide COVID guidelines and provide a summary of how they will adhere to current guidelines and educate participants of event of guidelines. Outdoor dining: The BOS have the ability to expand the premises to outdoor dining for local businesses. Working with town counsel to figure out the process to do that as it has changed since last year.

Lowlands Sewer Manhole Repair Bid.

TA: Part of our ACOP from DEP and in general, the DEP is pushing I/I systems. We have a gravity sewer that goes through the golf course and lowlands. This procurement is FEMA funded and is a project to replace the 8 manholes along that gravity line with water tight covers. So if we were to have a flood we wouldn't have salt water getting through the covers and into the sewer system. We had 4 bids. We opened them on March 11. The lowest bid was from N Granese and sons was \$38,020. The second lowest was Blue Diamond Equipment Company at \$54,400, Green Mountain Pipeline Services at \$63,021, and National Water Main Cleaning Company at \$78,700.



Dan Skrip (Town Counsel) – Max Mcdonough and I have been working together on this and we found some bylaws across the commonwealth that were approved and we took those and matched them together and tailored this bylaw for the town of Nahant. We are getting up to speed with other coastal towns. It won't affect a ton of people around town as we don't have many businesses. Showed the draft bylaw.

Max Mcdonough: This bylaw would reduce the use of plastic bags in town from restaurants and stores, the bags have a detrimental effect on coastal towns.

5. Preserving East Point

MC: During our last meeting a few residents had some questions.

First question was: Why did the town of Nahant join the two lawsuits between Northeastern and the Nahant Preservation Trust instead of consolidating it into one? We did so because we believe that is was in the best interest of the town to do so. The lawsuit was initially brought by Northeastern against not only the Nahant Preservation Trust but 28 residents as well. In turn those 28 residents and NPT brought suit against Northeastern as a means to protect the environment and preserve east point. We joined the lawsuit in hopes to have the land considered conservation land at east point. The aims of the lawsuit are consistent with the preservation of east point as a natural resource area as provided by town meeting actions 30

yrs ago and since exemplified by further development of lodge park. The town has its own claims in this case concerning Northeastern's promises to maintain east point as a wildlife preserve. Spoke about Nahant Preservation Trust and what they do for the town and how they give back. Joining forces with them strengthens our case.

Read more questions from residents regarding Northeastern and east point.

Ken Carangelo (resident)- Spoke about Northeastern expansion and the lawsuit.

Jeff Musman (resident)- Explained what the Nahant Preservation does and how it operates.

Jim Walsh (resident)- Spoke about the Northeastern expansion and eminent domain.

Diane Monteith (20 Seabreeze lane) - Thinks its healthy to have these informed discussions regarding northeastern.
