Discussion on Marijuana zoning by-law amendment

Dan and Daniel Skrip discuss procedures for holding a hearing before Town Meeting.

Shannon asks about the history of the proposed by-law and how it was proposed

Daniel Skrip responds that it came from the Board of Selectmen as a whole.

Dan, Sheila and Dan Skrip discuss if the number of licenses and if there are scenarios in which they could go higher than 1.

Shannon brings up questions from K Alice:

Do we know if there are any selectmen or family members have special interest in the pot industry There is no administering medicine in any pot establishments as far as I know. Where does growing come in? Residential areas should not have grow houses. Would cultivating need a permit?

Daniel Skrip says he knows of no interest from anyone's family members in the industry. And adds that the regulations will make it harder to open a marijuana establishment rather than make it easier.

Dan Berman says we are adding a layer of regulation and not allowing something that isn't already allowed

Steve Viviano wants to clarify that we are not making it easier to allow marijuana establishments

Dan says that because the town voted to allow marijuana establishments that we couldn't completely prohibit without having a town-wide referendum.

Dan suggests that there might be additional language restricting such establishments to Nahant Rd.

Sheila says that would have to be a zoning overlay.

Dan, Sheila, Shannon and Pat discuss the way a zoning overlay works and how it would be applied.

Cal, Sheila and Dan Skrip discuss the 500 ft from the school and that it is from the lot not the building. But Dan Skrip reads that it appears to be from the entrance.

Dan, Sheila, Shannon, and Dan Skrip discuss the warrant article process and what we can and can't do as part of the process. That we can't change the language before town meeting. We can recommend, not recommend or recommend with changes.

Dan, Pat, Shannon and Sheila discuss scheduling the hearing

Dan moves to schedule the marijuana b-law hearing Thursday April 29 at 5pm with an alternate Friday April 30 at 2pm and change the back-up date for the life saving station sign to alternative date of Monday April 26 6pm.
