Robin Stein shared a draft plan to the board and Sheila sent to members of the public.


Dan Berman shared the screen on the zoom meeting to begin reviewing the draft.

Robin Stein and Dan discuss specifying which terms have been released or not released and going through that list.

Dan Berman shares his screen and shows bk 6392 and pg 731 from the 1977 covenant. Discussion on paragraphs 2 and 3. Paragraph 4 can be left, but it is not relevant since there is town water and sewer. Discussion on paragraph 5. And paragraph 6 will also be left as-is.

Sheila asks about the right of way width being 23 +/- on the plans.


Cal Hastings asks about where the dead end street starts and whether that distance should be added to the calculation.
