1. Opening Remarks and Discussion on Spouting Horn Subdivision

Chairman Cal Hastings - opening remarks planning board counsel preparing a report for planning board for Sept 15 hearing.

Stephen Smith reviewed history and status of the lots on Spouting Horn Rd

Chairman Cal Hastings discussed awaiting the legal basis of authority to approve subdivision

Stephen Smith asserts that covenant with planning board allows for subdivision if planning board approves.

Cal Hastings discussed some gaps in the public record, issues with the road not being a public way, whether the town maintains the road. Whether all the stakeholder boards and departments have submitted the required letters. Emphasized need to have all reviewing agencies, especially emergency services, give feedback and document their review of access to the subdivision.

Stephen Smith Presented September 2019 letters were received by planning board. Discussed status of actions by planning board.

Shannon Bianci reports that letters to abutters and reviewing agencies will go out in the mail tomorrow 8/28/2020

Francis Valenti – Recounted history of the process, expressed disappointment with length of process, steps taken to address the planning board's concerns and lack of communication on what would be necessary to gain approval.

Chairman Cal Hastings – Reiterated awaiting report from counsel and would do whatever is right. Moving on to next topic

2. Northern Strand Discussion

Dan Berman update on northern strand community trail. Route from Market St to Nahant Rotary would eliminate right hand lane.

General comments from multiple planning board members expressed concerns about the loss of a lane into the Nahant Rotary and lack of planning engagement with Nahant.
