#### 4. Communication on ZBA

Chairman Cal Hastings – Discussion on what is our role with ZBA.

Vice Chairman Daniel Berman - We can comment on matters before the ZBA

Chairman Cal Hastings – Commented that sometimes things can go back to the building inspector,

sometimes things come back without being submitted by a certified professional engineer and should be rejected.

Sheila Hambleton - If accepted by building inspector then... not clear

Daniel Berman - Suggested we need to comment to ZBA and building inspector

Steven Viviano - Building inspector will deny with letter and sheet of paper with a checklist and 14 copies which go to ZBA members and one set to con comm., one set to planning board and one set board of selectmen. That the various town committees should better communicate between committees.

Sheila Hambleton - Change of use would require special permit and ZBA and planning board are both the authority for some special permits.

Chairman Cal Hastings - If there is no plan by a certified engineer it should go back to the building inspector and then the applicant

Steven Viviano - As a board we have struggled with what the requirements are for homeowners coming forward with issues.

Cal Hastings - Alterations to houses and additions need to have a plan. Everything that goes to the ZBA needs to also come to the planning board. And we should also tell the building inspector. Shannon Bianchi - Posted section 9.08 of the zoning bylaws showing that the planning board is the special permit granting authority for: "1. If the proposed use or structure is in a B-1 or B-2 District and, Consists of a change of use for more than 1,000 square feet of gross floor area within an existing structure, or the building of a new structure exceeding a gross floor area of 500 square feet (within any 12 month period), then the Planning Board shall act as the SPGA and site plan review shall be required, as set forth in Section 9.09.

Steven Viviano - Suggests that Steve Smith might walk us through the permitting process from his perspective.

Cal Hastings – Stated that there is a process and it should be followed

Steven Viviano – Commented that it can be a convoluted process.

Patrick O'Reilly - Stated if there are issues with the current process that need to be addressed it would be good to get feedback and make whatever changes are necessary to either the process or recommend changes to the bylaws to town meeting.
