#### a. Comcast Contract Renewal

**Dan Skrip (Town Counsel)**: We have both Contrast and Verizon Contract Renewals coming up and will need to have a public hearing to approve a 10 year renewal lease.

## b. Vote to accept Green Communities Competitive Grant Award

**TA:** We received this grant award in the amount of \$103,863. \$30,220 is for the Fire Station to install an air source heat pump, \$18,125 is to install an air source heat pump at the DPW, \$46,076 is for Johnson School to complete phase 2 portion of internal led lighting conversion, \$9,442 is for the Administrative Assistant of the grant.

## c. Northern Strand Extension Update

**TA:** shared his screen to show concept for the extension. MASS DOT sent out the 70% completion plan. Discussed the plans further.

#### d. Willow Road and Wharf Street Intersection MBTA Bus Stop improvement update

**TA:** We are working with the MBTA to make ADA improvements to crosswalks. We did one in Little Nahant and now the one at Willow/Wharf intersection. There are no ADA curb cuts or crosswalks or sidewalks where the bus stop is. This design would move the bus stop and crosswalks, fix the sidewalk, install ADA ramps at the crosswalks **Brendan Baranek-Olmstead (2 Summer St):** I noticed on the Summer St. side the arc of the sidewalk on the road is different and is filling in part of the Street. Will this be a problem for the Fire Dept. to turn? Is there anything about the pump station there that will be effected and can any improvements be made?

**TA**: we will maintain the width of the street and turn. We may need to move some manholes but will be fine.

**e.** *Pickleball Group Request- Discussion*: Install lines and temporary nets at the Flash Road Tennis Courts for Pickleball use.

**Sandy Burton:** the pickleball group has put temporary Pickleball courts with tape on one of the tennis courts. Next year we will submit CPC grant to help fund changing one of the courts into a permanent pickleball court.

**TA**: The original funding for the new basketball and tennis courts came from a CPC grant which the towns people voted on and it did not include any language for pickleball. If people want one of the courts to be changed to pickleball then you would need to go through that CPC grant process again to have it approved and funded.

Pan Manadee (122 Wilson Rd.): Commented on the Tennis courts and changing them into pickleball courts.

#### 6. Preserving East Point

JA: The next hearing for Article 97 is October 31st.

#### 7. Town Administrators Report

**TA:** Final connections and testing of the lines on the lynnway sewer project will be done and will be decommissioning the bypass. Pavement procurement bid opening tomorrow. We submitted our Hazard Mitigation Grant Application for \$3.5 million for the short beach dune mitigation project.
