Minutes of Joint Advisory and Finance Committee and Board of Selectmen Meeting July 14, 2022

Members Present from Advisory and Finance Committee: Beatty, Brown, McMackin, Sheehan, Vanderslice, Warren

#### Canty called the meeting to order at 3:00PM

Town Administrator Barletta explained that the Municipal Modernization Act allows a vote of both the Board of Selectmen and the Finance Committee to move funds from different accounts to balance the town's budget. The meeting can occur within the fifteen days leading up to the end of the fiscal year through the fifteenth day after the end of the fiscal year. The Board of Assessors needed additional transfers to balance their budget. They had identified several Assessor's accounts with unspent balances. Barletta and Nieto had identified an external account with an unspent balance.

Assessor Hambleton thanked us for meeting and explained that she needed to transfer funds to cover a revision in the cost of purchase of services due to a shortfall caused by the cost of certification. She had identified an unspent balance of \$2474.76 in her budget, including \$344.66 in the salaries and wages account that could be transferred to the general expenses account and be applied to the \$7,132.10 outstanding bills. By subtraction, an additional \$4,657.34 would be needed to cover the full amount. She explained that the final certification in process, which was costly, required these expenses. She also mentioned possible future lawsuits before the Appellate Board which she thought the town should be aware of.

Cullinan asked why this wasn't acted on at Town Meeting.

Nieto explained that we did not know about these invoices then. She and Barletta had identified the \$344.66 in unspent salaries and more from the external IT account that would make up the needed \$4,657.34.

Sheehan moved that \$344.66 from Assessor's salaries and wages accounts be transferred to the Assessor's Purchase of Services account. McMackin seconded. Beatty, McMackin, Sheehan, Vanderslice, and Warren voted Aye; Brown abstained. The motion passed.

In the discussion, Cullinan said that he hoped such late transfers would not happen again, after Town Meeting. Barletta explained that the invoices could have been held for approval at the 2023 Town Meeting but that this would incur interest, so thought better to approve now.
