The Chairman then turned to the proposed recommendation relating to the proposal of the Short-Term Rental Zoning By-Law Advisory Committee ("STRC") and read through the entire recommendation asking for views and changes after each comment. Sheila asked whether the document summary will be attached and Rob noted that it will accompany the document. Steve said a combination of both proposals would be helpful. Sheila said short term rentals are not allowed, and citizens will be worried about not know how they will be specifically regulated. A variance not a special permit needs to be issued by the ZBA. Sheila said it will be changed to a vacation destination, and it will impact the schools and the age group.

Patrick said it is a special permit process because the amended by-law will make the short-terms legal. The Chairman noted that Nahant won't become a mecca for short-term housing given the cap and the fact that we did not see a spike of short term rental purchases when interest rates were at 3% because Nahant does not have the amenities to draw people.

Rob said that Sheila is technically right and we have a problem, and are choice is h keep the status quo (that I haven't heard anyone endorse) or do something to correct it. The STRC proposals allows for corrective action.

Discussion then ensued about additions to the comment section to address Sheila's comments. The additions were developed and were as follows:

Paragraph 8 addition: The Planning Board expects that the Board of Selectmen will have regulations for short-term housing completed and ready to approve by no later than November 1, 2023.

Added Paragraph 9: The Planning Board views enforcement of short-term housing regulations and, in particular, the cap limitation, as extremely critical, and expects the Town will take necessary steps to ensure compliance.
