Council of Aging Minutes for Meeting on September 13, 2023

A motion was made by Donna Steinberg to accept the July Minutes. Seconded by Linda Jenkins. Unanimous vote.

Emily gave her Financial Report. Operating Budget will be updated. The Budget is on track for the year.

Lolli Ennis motioned to accept the Financial Report. Carol Sanphy seconded. Unanimous vote.

Town Administer, Tony Barletta visited the meeting to discuss the Kitchen project, and information received by Architect Vance, and the Estimator report. The Board agrees that the Estimate is very high. It was discussed that it would be prudent to get more than one estimate from other Architects. The discussion of the possibility of using Johnson School may be better due to the opportunity for COA to have the space for future expansion. Eligibility for grants for the creation of the kitchen could be received due to the school being a shelter in place bldg. A decision can be made after, to use the Johnson School, when the additional estimates come in. Tony will call Groom Co. for an estimate for both the Town Hall Kitchen and the Johnson School. It also was suggested to get at least one more Architect to give an estimate. These estimates will help in getting the approval of the Johnson School Board for the project. Costs then will be compared to help decide which building would be used. All including Tony agrees that time is of the essence.

Tony stated that the 50K grant couldn't be used in time, so an extension has been requested. The Town is paying for all estimates received for the project. There has been no commitment made to Vance as of yet. Board members will tour the School in small groups to get more familiar with the space. Mary will take arrangements and will contact Members.

Directors Report: Michelle Roberto-Marshall is no longer working at the Senior Center. Penny Morse is expanding her hours. Penny is well versed in how the COA runs and is a much welcome addition. A Title 3 Grant has been applied for from GLISS. Memory Cafe will now be called This revival will bring in Music, Art etc. to the program. Peter Barba reported that the Black Tie fundraiser will be giving approx. \$7,500 to the Friends of the COA. It was a great event and is greatly appreciated. It was suggested that we change the COA Meetings to the FIRST Monday of every month at 10:00. This will help in scheduling of the meeting room.

A Motion was made by Donna Steinberg to change the meeting day. Linda Jenkins 2nd. Unanimous vote.

The lunch cost for Seniors will be raised one dollar from \$4.00 to \$5.00 due to food costs. It was asked if scholarships are available for Seniors who may have difficult paying for lunch. St. Vincent De Paul Picks up the cost for anyone eligible.
