3. Coast Guard Housing Update

TA: All 9 (nine) properties have been demolished down to the foundation. There was 8 underground storage tanks associated with those properties and no contaminated soil was found with those. We began demolishing the foundation of some of the properties and there was some transient duck work pipe discovered. We are working with DEP to properly remove it. We are expecting the foundations will be fully removed shortly.

b. Short Term Rental By-law approval by Attorney General and next steps

Dan Skrip (Town Counsel): We got a decision last week from the Attorney Generals office and it approved both portions of Article 22, both A and B. The rules and regulations will not go into effect until 120 days have passed since the Town Clerk has posted the bylaw. That was posted last week. So the BOS have 120 days to come up with the rules and regulations that will go into effect right around March 1, 2024.

The second portion that was approved was the zoning bylaw- the AG passed/approved and said we were not in violation of state law or state constitution. They did address some 4th amendment issues that was raised by opposition of residents in Town. The AG said there were no issues with that amendment or violations.

George Mihovan (64 Lennox Rd.): Asked a question about the Attorney General's response and the next steps Michelle Capano (29 Ocean St.): Asked about rental properties and how the Town will enforce compliance to residents not abiding by the new bylaw
