Warrant Article (Title and language.) **DPW/Infrastructure Capital- Lowlands Drainage**

To see if the Town of Nahant will vote to appropriate up to \$800,000 or any sum of money, to implement the Dubois and King, Nahant–Stormwater Improvements- Alternative (1) – Lowlands 18” Outfall Restoration, by constructing permanent fixed pump at the juncture of Castle Road and Fox Hill Road to direct storm water to Lynn Harbor, and Alternative (2)–Lowlands Stormwater System Improvements; including the addition of storm drains, water catchment areas, and curbing in the Lowlands (Castle Road, Ward Road, Fox Hill Road, and Castle Way), in order to improve drainage in the Lowlands and the safety of all Nahant Residents; and will include the payment of all costs incidental or related thereto, and to determine whether this appropriation shall be raised by borrowing or otherwise, or to take any other action relative thereto.

We, the undersigned registered voters of Nahant, do hereby petition the Board of Selectmen pursuant to MGL Ch. 39, S. 10 to include the above Article in the Warrant of the next Annual Town Meeting
