1 NAHANT ANNUAL TOWN MEETING 2 Monday, September 27, 2021, 7:10 p.m. 3 4 TOWN MODERATOR: Okay. So, as I said, I've checked out the return of service and everything is 5 6 in order so we can proceed. 7 And Jeff Antrim will give us -- will lead us 8 in the Pledge of Allegiance to the flag. Jeff? 9 Josh, sorry. Josh going to do it. 10 (Pledge of Allegiance Recited) 11 TOWN MODERATOR: Thank you, Josh. 12 (Applause) 13 TOWN MODERATOR: All right. So, we have some 14 non-voters on the floor; Hannah Chadwick from the Item, 15 Jeff Blake, Matthew Vadetta, Tony Barletta, Zach Taylor, 16 Tom Simbro, and Stephanie Salerno. 17 Are there any other non-voters on the floor? 18 Yes? 19 MS. TAMBRY: Allison Tambry (ph). 2.0 TOWN MODERATOR: Allison, all right. All right. 21 You're on. 22 Okay. I think we're ready to go, and so, we 23 will call Motion Number One. 24 Julie Tarmey.

MOTION NUMBER ONE

MS. TARMEY: I move that the Town appropriate the sum of \$3,000,000 to pay costs of improvements to the Nahant sewer collection system, including the payment of all costs incidental and related thereto; that to meet this appropriation, the Treasurer, with the approval of the Board of Selectmen, is authorized to borrow said amount under General Laws, Chapter 44, Section 8, or any other enabling authority, and to issue bonds or notes of the Town therefore, that all or any portion of this amount may be obtained through the Massachusetts Clean Water Trust, (The Trust); that the Board of Selectmen is authorized to contract for and expend any federal or state aid available for the project, and to enter into any agreements with the Trust or the Department of Environmental Protection of the Commonwealth that may be necessary in order to obtain assistance through the Trust, and that the Board of Selectmen is authorized to take any other action necessary or convenient to carry out this project, and that any premium received upon the sale of any bonds or notes approved by this vote less any

premium applied to the payment of the costs of issuance of such bonds or notes may be applied to the payment of costs approved by this vote, in accordance with General Law, Chapter 44, Section 20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.

TOWN MODERATOR: Seconded by Ms. Warren.

Discussion on the motion? Mr. Barletta?

MR. BARLETTA: Good evening. My name is Tony Barletta, I'm the Town Administrator and I want to thank you all for coming out tonight.

I was very nervous this morning throughout the day that we wouldn't get the quorum, so I really appreciate all of you coming tonight on this important subject, and for that, I will be very brief.

But we have everyone here that can answer any questions about this issue that you might have before we take the vote.

Tonight, the motion is to authorize the borrowing of an additional \$3,000,000 for this major capital need. Our most important capital need is our sewer force main pipe, so the pipe that takes all of our waste water from the Ward Row pump station to the treatment plant in Lynn, and this project is focused on the section

of the pipe that's in most critical need of repair from the rotary to the treatment plant.

Now, we have previously borrowed funds, and if you read the letter in the first page of the book, you know the story.

But we've previously borrowed funds for this project. We've procured an engineering firm to do an assessment and essentially tell us all of our possibilities and options to make these repairs, selected the most cost effective timely option to make those repairs, and we've now gone out to bid.

The lowest bid that we received, while higher than our estimated cost, is a highly qualified competitive bid, and it's actually a good price for the current economic environment.

And lastly, I'll say is that after -- the last time we talked about this in September of 2020, the day or two days after that meeting, we experienced another sewer main break, and Mass DEP hit us with an administrative consent order that requires that we make this repair by the end of this calendar year.

So, really what we're up against here is, first of all, the need, because we've spent over \$2,000,000 in repairs in the last three years, a requirement

- 1 under the administrative consent order to make this
- 2 | -- to get this job done by the end of the year,
- 3 and waiting, we risk more costs to the Town because
- 4 of either additional breaks, fines under that
- 5 administrative consent order, or having to re-bid
- 6 | the project and potentially getting higher bids under
- 7 | that environment.
- 8 So, as I said, we're happy to answer any questions
- 9 that you might have. Tom Simbro from Wright Pierce, our
- 10 | engineering firm is here and can answer any technical
- 11 questions, as well. Thank you.
- 12 TOWN MODERATOR: Thank you.
- 13 Further discussion on the Article?
- 14 Yes, sir? Please stand at the podium and identify
- 15 | yourself and your --
- MR. SPIRN: Hi. I'm Paul Spirn, and I live on
- 17 Maolis Road.
- Tony, would I be wrong if I observed that a lot
- 19 of our trouble with our sewer mains occurred on the
- 20 Lynnway in an area that over the past couple of years
- 21 has seen a terrific amount of construction?
- MR. BARLETTA: No, you wouldn't be wrong, however,
- 23 | we've found that a lot of the cause of the breaks that
- 24 | we've experienced isn't from construction, it's actually

from electrolysis.

So, we have a pipe that was installed in the early '80's that the material of that pipe suffers from corrosion caused by electrolysis, which under the Lynnway are existing gas mains, electrical conduit, and it's sitting in a salt marsh.

So, essentially, stray current finds its, you know, closest point to ground, hits our pipe, and that's where a lot of the corrosion, where the breaks have been caused by. Instead of like a break that you would see where the pipe splits in a nice form, it's like a corroded hole like the size of a football or a softball or things of that nature.

So, the fix, the repair job that we're proposing is a plastic product that has a 50-year life span and doesn't suffer from that same corrosion activity.

MR. SPIRN: Okay. I assume that the new material you're putting in more or less follows the course of the preexisting piping; is that right?

MR. BARLETTA: It actually sits in the existing pipe.

MR. SPIRN: Okay. Couldn't be closer.

So, I presume also that we have an easement to use that right-of-way across property which I guess

is mostly Lynn, I don't know, maybe some of it is state property, but in any case, what protects us from a situation where physical damage really is done to the pipe when it's not on Nahant property?

MR. BARLETTA: It's a good question. I mean, in any situation that we've ever experienced, even in Nahant, on Nahant property, if National Grid was doing a job, if a private contractor was doing a job and they struck our pipe, they would -- we would essentially go after them for the cost of that repair, or they'd be forced to repair it right then on the spot.

MR. SPIRN: Right. So, it's part of your due diligence when there's damage to our equipment to see if anyone else is responsible?

MR. BARLETTA: Yes, yes.

MR. SPIRN: Okay. Thank you very much.

TOWN MODERATOR: Thank you.

Further discussion on the motion?

19 Yes, sir?

MR. LEWIS: Jeff Lewis, 6 Ellsworth Road.

Question on useful life. I ready the engineering summary, and you're recommending the slip line, and they also said that that section, the Lynnway section, was experiencing up to 76% corrosion.

Does that have any impact on the useful life of the product?

MR. BARLETTA: Well, I will -- I've asked this question myself, so I'll attempt to answer it myself, but jump in if I get anything wrong.

The slip line, the plastic pipe that we're actually inserting inside the existing pipe, will become the new pipe. It is structural, it is sound, it has 50 year life.

So, it uses the existing pipe to pull through, but once this project is done, the outside, the old pipe, can corrode to nothing and it will not impact -- the structural integrity doesn't rely on the old pipe that can disappear; correct.

MR. LEWIS: That's my question.

TOWN MODERATOR: Thank you.

Further discussion on the motion?

18 Yes, ma'am?

MS. ROGERS: Bea Rogers, 44 Pearl Road.

This obviously is non-optional, I am not proposing that we rethink it.

But I'm just curious if there's a lot of federal infrastructure money floating around, is there some way that we might access that now or in the future?

MR. BARLETTA: Thank you, Bea.

There's certainly federal and state funds out there that we can -- that we will be pursuing actively, even beyond this job. Unfortunately for us, we are in a tight timeline.

MS. ROGERS: Yes.

MR. BARLETTA: So, we reached out to the state, because the Governor just announced that he was going to be using a lot of his American Recovery Act money towards sewer infrastructure, but the process that that is going through the legislature is going to be -- it's going to take too long.

So, there is -- when you read the administrative consent order and all the different things that we're required to do and look at, there is a lot of sewer infrastructure and water infrastructure that, you know, we have to take care of in the future, and that's where we're going to use -- we're going to try to get money from the federal government and the state government to help us with that.

Under this motion, it's read to allow us to borrow under the Trust. In September of 2020, the Town approved a \$4.6 million borrowing through the Trust. It's a low interest loan, it's 2.25%, whereas if the Town were to

borrow ourselves, I think it's 3% -- or I'm sorry, the
loan is 2% and then Town would be 3.5%.

So, when this occurred, we reached out to the Trust and we asked them if we were to go to Town Meeting and ask for additional borrowing, could we take that authorization and add it to our previous award under the low interest loan program, and they said yes.

So, it saves us about a half a million dollars going through their program versus borrowing it on our own. So, we are taking advantage of a state program, unfortunately, it's a loan and not a grant, but we'll definitely be pursuing those other funds for future projects.

MS. ROGERS: Thank you.

TOWN ADMINISTRATOR: Thank you.

Further discussion on the motion?

Yes, ma'am?

MS. GRADY: Hi. I'm Ann Marie Grady. I live at 4 Rosemary Road.

And I've been reading the words in the Article, and I'd like to know what the price cap is on the authorization? It says any amount greater than \$3,000,000. Seems to me that goes to infinity.

MR. BARLETTA: So, it's kind of standard

- language for an Article to say that. Bond counsel wouldn't allow us to borrow a significant amount over \$3,000,000.
 - I think the point of that language is if it ends up being like \$3,000,001, you know, a little bit more or a little bit less, --
- MS. GRADY: Why couldn't it say \$3,000,000 plus

 or minus ten percent or twenty percent, or --
- 9 MR. BARLETTA: Jeff, do you mind answering 10 that question?
- MR. BLAKE: No.

- MR. BARLETTA: Jeff Blake is our Town Counsel.

 Like I said, it's more of a legal language question.
- MR. BLAKE: Good evening everyone and thank you

 for having me. As you know, my name is Jeff Blake.
- The Article itself said essentially \$3,000,000, more or less, but the motion --
- MS. GRADY: More or less?
 - MR. BLAKE: -- but the motion said \$3,000,000, so when we look at authorization to borrow, through this motion, you've only been authorized to borrow \$3,000,000. That, of course, includes any lesser amount, but not any greater amount.
- MS. GRADY: That is the cap then?

1 MR. BLAKE: So, that's the cap. MS. GRADY: Thank you. 2 3 TOWN MODERATOR: Thank you. Further discussion on the motion? 4 5 Yes, sir? MR. BARBA: Pete Barba, 22 Emerald Road. 6 7 Because this is a loan, are we able to apply for grants and kind of back-pay that loan? 8 9 MR. BARLETTA: We're certainly going to try. 10 Usually, I'll be honest, usually, it's not a very 11 competitive request when there's, you know, so many 12 towns, and especially when it's sewer infrastructure 13 dollars, it's millions and millions of dollars. Every 14 town is facing the same struggle. 15 So, it's not very competitive when you're asking 16 for money to pay back for a project that you've already 17 built, but we're definitely going to try. 18 TOWN MODERATOR: Further discussion on the motion? 19 Yes, ma'am. 20 MS. BARBACOFF: Gloria Barbacoff, 22 Fox Hill Road. I had a question about the plastic, this pipe slip. 21 22 Is there any danger of it degrading and polluting the

environment? Does anybody know that?

23

- 1 MR. SIMBRO: The pipe that we're using is all 2 NSF 61, which means it's made to go over water. 3 MS. BARBACOFF: Okay. MR. SIMBRO: And the life of the product is a 4 minimum of 50 years. 5 MR. BARLETTA: So, Tom said the product is made 6 7 for this job and it has a life span of a minimum of 50 years. 8 9 MS. BARBACOFF: Okay. Thank you. 10 TOWN MODERATOR: Further discussion on the 11 motion? 12 Yes, ma'am. 13 MS. DOLAN: Janet Dolan, 45 Pleasant Street. 14 My question is, what is the plan for the future 15 in terms of maintenance of this new pipeline or piping 16 going in? 17 MR. BARLETTA: Well, the design of this new 18 project actually enhances our ability to maintain it. 19 Under the current structure, it has air release valves 20 along the pipe that have been somewhat inoperable or tough to get at. 21
 - So, through this project, we're actually going to build larger manhole areas that we can access and better maintain this pipe.

1 Once this job is complete, there are other sewer 2 needs that are going to rise above in priority, like 3 the Willow Road main or the other functions of the Ward 4 Road pump station and other aspects of our system. 5 should be pretty good, but like I said, we're going to 6 actually enhance our ability to maintain this pipe 7 through this project. MS. DOLAN: Okay. Thank you. 8 9 TOWN MODERATOR: Thank you. Further discussion? 10 11 Yes, sir? 12 MR. ROBERTS: Sean Roberts, 17 Highland Road. 13 I call the vote. 14 TOWN MODERATOR: Ah, the vote has been called for. 15 So, two things. First of all, we have to vote 16 on the motion to call the question, and two-thirds is 17 required, no debate. 18 So, those in favor of calling the question, 19 signify by saying "Aye." 20 ATTENDEES: "Aye." TOWN MODERATOR: Those opposed, "No." 21 Unanimous vote in favor. 22 23 (Applause) 24 TOWN MODERATOR: So, I love unanimous votes.

I mean, it just does everything for you, and 1 2 this is a borrowing Article, so we need a two-thirds majority for this motion, as well. 3 So, now we're going to vote on the motion, and 4 5 if we got another unanimous vote, then we wouldn't have to stand up and count, so that would be very nice, but 6 7 it's up to you guys. So, those in favor of the motion, signify by 8 9 saying, "Aye." 10 ATTENDEES: "Aye." 11 TOWN MODERATOR: Those opposed, "No." 12 Unanimous vote in favor. So approved. 13 (Applause) 14 TOWN MODERATOR: Thank you all for coming tonight. We were all a bit worried, but we know the Town wants 15 to make the Town. 16 17 And Bea, how is it that you can speak through 18 your mask and everybody can understand you and nobody 19 else? 20 The business of this meeting being completed, this meeting stands dissolved. 21 (Special Town Meeting Concluded at 7:30 p.m.) 22
