Review of the Master Fee Schedule and proposed changes for FY25. TA shared his screen to show the FY24 Fee schedule.

- 4. Ongoing Business
  - a. Housing Production Plan next steps

**JA:** the Housing Production Plan has been prepared by the Housing Production Committee with the help of MAPC over the last few years. This plan does not give us safe harbor from an unfriendly 40B development. The plan is with the Planning Board

*TA: It's the next step in the process.* On May 21<sup>st</sup> at their meeting they determined to indefinitely postpone the May 7<sup>th</sup> version of the Housing Production Report and at their last meeting they decided to not discuss the latest version. There has not been a vote by either board to accept the plan. The Planning Board requested to see an updated version of the

plan at least 2 weeks before a joint vote would be taken with the Planning Board and Selectmen before accepting and sending to the State. The Housing Production Plan Sub-Committee did forward the latest version to both committees and the Planning Board responded within their last two meetings about the plan.

**Rob Steinberg (Chair of Planning Board):** We had a meeting last night and the minutes reflect that we did not take up the agenda item of how the Planning Board wishes to move forward with the plan. The Planning Board made a request to assist in preparation of a plan, either its own plan or a modification of material developed by the Housing Plan Committee. Moving forward there are members of the Planning Board that want to look into the postponement of the May 7<sup>th</sup> plan consideration, whether that means we can't review any materials or build on what the housing production committee developed.

## b. Northern Strand Extension Project update

**TA:** This project will be starting this year. Our community has voiced a lot of support but also a lot of concern over the current plans. We reached out to the State and had meetings with State Legislatures and officials with the City of Lynn and DCR about our concerns. We have information on our website about the process and project. We talked to them about changing the design and putting it on the other side of the Lynnway where there is less traffic, expressed the need for the extra lane inbound to Nahant, a seasonal lane, shortening the bike path. We met on site and asked permission to pay for a traffic study of a mock bike path. None of this gained any traction to help change it. We support the project but with less negative impacts to our residents.

## 5. Preserving East Point

## a. Eminent Domain update and Q&A session

*JA:* On April 16<sup>th</sup> the summary judgement ruling was made that the taking of the land was unlawful. The taking was to put a conservation restriction on part of the land. Northeastern submitted a damages claim for approx. 25 million. Nahant was given 10 days to respond to damages, we then requested a stay of 30 days and the judge denied. The judge reviewed the damages claim and called for an emergency hearing on May 14<sup>th</sup> where the judge granted Nahant 60 days to respond to the damages claim.

#### 6. Town Administrators Report

Andrew Smith (Engineer): Gave an update on the Ward Rd. Pump station project.

**TA**: Gave an update on the Sumner Tunnel Closure. Update on installing new water meters to residents in the future, they will provide a more accurate reading. Fourth of July will have fireworks and wharf party. We received 5 marketing proposals for the Coast Guard Housing Properties. The next step is for the review committee to review them. We are also working on the RFP for the sale of the lots.
