Pursuant to the statutory requirements of Massachusetts General Laws Chapter 40A, section 5, notice is hereby given that the NAHANT Planning Board will hold a hybrid public hearing on MARCH 25, 2025, via Zoom and in Conference Room #2, Nahant Town Hall, 334 Nahant Road, Nahant, starting at 7:00 PM on a proposal from the Nahant Planning Board seeking to 1.) amend the Nahant Zoning By-Laws by adding Section 15: Nahant Protected Use Accessory Dwelling Units; and

2.)amend Table of Use Regulations, Section 4.13, Table 1. The purpose and intent of this bylaw is to comply with State’s Section 8 of Chapter 150 of 2024, also known as the Affordable Homes Act.
