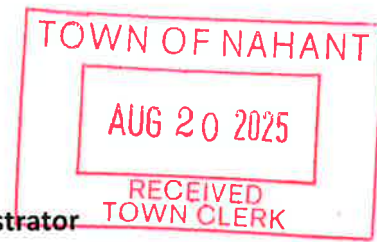


Town of Nahant
